Notice is hereby given that the Borough Council of Bolton have made an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984.

The effect of this Order which will become operative on the 13th July 1992 is as follows:

Waiting limited to 40 minutes return prohibited within 1 hour 20 minutes 7.30 a.m. to 6.30 p.m. Monday to Saturday

- St. Georges Street, south side from 15 metres east of Higher Bridge Street to 5 metres west of All Saints Street;*
- St. Georges Street, south side from 15 metres east of All Saints Street for 40 metres in an easterly direction;*
- St. Georges Road, north side from 15 metres west of Wickliffe Street for 40 metres in a westerly direction;*
- St. Georges Road, north side from 5 metres east of Wickliffe Street for 30 metres in a westerly direction.*

This Order will contain exceptions to permit waiting for certain purposes and limited waiting by disabled persons' vehicles.
