### OPENCAST COAL ACT 1958

#### *High Cross (Suspension of Public Rights of Way) Order 1992*

1. Notice is given that on 26th June 1992, the Secretary of State in the exercise of his powers under section 15 of the Opencast Coal Act 1958 on the application of the British Coal Corporation, made the High Cross (Suspension of Public Rights of Way) Order 1992 suspending the rights of way described below.

2. The Order will come into operation on 10th July 1992, and will suspend the rights of way until the Secretary of State revokes the Order.
