TOWN AND COUNTRY PLANNING ACT 1990

The City of Newcastle-upon-Tyne Kenley Road, Denton Dene, Public Path Diversion (No. 1) Order 1992

Notice is hereby given that the Secretary of State for the Environment in exercise of the powers conferred on him by section 247 of the Town and Country Planning Act 1990, and all other powers enabling him in that behalf has made an Order entitled The City of Newcastle-upon-Tyne, Kenley Road, Denton Dene Public Path Diversion (No. 1) Order 1992, the effect of which will be to divert a length of public path starting from a point at the south-east end of Kenley Road and running in a southerly direction onto a new line starting at a point at the south-east end of Kenley Road and running in a generally south-easterly direction then a south-westerly direction to a point on the footpath.

A copy of the Order and the map contained in it has been deposited at the offices of the City of Newcastle-upon-Tyne, Metropolitan District Council, and may be inspected free of charge at the Council Offices, Department of Law and Administration, Civic Centre, Barras Bridge, Newcastle-upon-Tyne and Denton Burn Public Library, West Road, Newcastle-upon-Tyne, during normal office hours.

The Order becomes operative as from the date of publication of this notice but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act 1990, or on the ground that any requirement of that Act, or of any Regulations made thereunder has not been complied with in relation to the making of the Order he may under section 287 of the Town and Country Planning Act 1990, within 6 weeks from the date of publication of this notice make application for the purpose to the High Court.
