Given at Our Court at Buckingham Palace, this fifteenth day of July in the year of our Lord One thousand nine hundred and ninety-two and in the forty-first year of Our Reign.

## DEPARTMENT OF TRANSPORT

### TOWN AND COUNTRY PLANNING ACT 1990

#### *Town and Country Planning General Regulations 1976*

The Secretary of State for Transport hereby gives notice that he has made an Order entitled "The Extinguishment of Vehicular Rights (County of Derbyshire) (No. 1) Order 1992". The Order comes into operation on 20th July 1992, and extinguishes any right which persons may have to use vehicles (other than those specified in Schedule 2 to the Order) in an area of unclassified highway at Bobbin Mill Lane, Chesterfield, Derbyshire, measuring 14.8 metres from its junction with Walton Road in an easterly direction.

Copies of the Order may be obtained, free of charge, by applying to the Director of Network Management and Construction, East Midlands Region, Department of Transport, Room 805, Cranbrook House, Cranbrook Street, Nottingham NG1 1EY (quoting ref. No. EMMCM 5050/41/17/15) and may be inspected at all reasonable hours at the offices of the Chesterfield Borough Council, Town Hall, Rose Hill, Chesterfield, Derbyshire.

If any person aggrieved by the Order desires to question its validity, or the validity of any provision contained in it, on the ground that it is not within the powers conferred by the above Act or that any requirement of that Act or of any regulation made under it has not been complied with in relation to the Order, he or she may, within 6 weeks from 20th July 1992, apply to the High Court for the suspension or quashing of the Order or of any provision contained in it.

Unless the Order is suspended or quashed as a consequence of any such application, any person who on 20th July 1992, has/had an interest in land having lawful access to a highway to which the Order relates may claim to be entitled to be compensated by the Chesterfield Borough Council in respect of any depreciation in the value of his or her interest which is directly attributable to the Order and of any other loss or damage which is so directly attributable to the Order and of any other loss or damage which is so attributable. Any claim must be served on the Council at its above address within a period of 6 months from 20th July 1992, unless the period is extended in any particular case by the Secretary of State.

Unless the Order is suspended or quashed as a consequence of any such application, any person who on 20th July 1992 has an interest in land having lawful access to a highway to which the Order relates may claim to be entitled to be compensated by the Worcester City Council in respect of any depreciation in the value of his or her interest which is directly attributable to the Order and of any other loss or damage which is so attributable. Any claim must be served on the Council at its above address within a period of 6 months from 20th July 1992, unless the period is extended in any particular case by the Secretary of State.

### TOWN AND COUNTRY PLANNING ACT 1990

#### *The Extinguishment of Vehicular Rights (County of Hereford and Worcester) (No. 1) Order 1992*

Made 20th July 1992

The Secretary of State for Transport makes this Order in exercise of his powers under section 249 of the Town and Country Planning Act 1990, and of all other enabling powers.

1. Save as provided in article 2 below any right which persons may have to use vehicles on the highways described in Schedule 1 to this Order and shown on the deposited plans is hereby extinguished.

2. The provisions of article 1 above shall not apply to the use of vehicles in the cases specified in Schedule 2 to this Order.
