ROAD TRAFFIC REGULATION ACT 1984

*The Trunk Road (A4060) (Merthyr Tydfil, Mid Glamorgan)  
(De-restriction) Order 199*

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under sections 82 and 83 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to de-restrict those lengths of the trunk road described in the Schedule to this notice.

A copy of the proposed Order together with a plan and a statement of reasons for the making of the Order, may be inspected, free of charge, during normal office hours at the offices of Merthyr Tydfil Borough Council, Civic Centre, Merthyr Tydfil, Mid Glamorgan.

Objections, specifying the grounds on which they are made, and quoting ref. ZC 510-6-5-5 must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Llanishen, Cardiff CF4 5PL, by 12th August 1992. ## SCHEDULE

Those lengths of the trunk road at Merthyr Tydfil in the County of Mid Glamorgan comprising:

- (a) that length of the northbound carriageway of the trunk road which extends from a point 20 metres north of the centrepoint of Lower Pentrebach Roundabout for a distance of 220 metres in a northerly direction;
- (b) that length of the southbound carriageway of the trunk road which extends from a point 270 metres north of the centrepoint of the Lower Pentrebach Roundabout for a distance of 250 metres in a southerly direction;
- (c) that length of the trunk road which extends from a point 120 metres north of the Mountain Hare Roundabout to a point 140 metres south of the centrepoint of the Mountain Hare Roundabout. (492)

ROAD TRAFFIC REGULATION ACT 1984

*The Trunk Road (A4060) (Merthyr Tydfil, Mid Glamorgan)  
(Prohibition of Right Hand Turns) Order 199*

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1, 2 and 124 of the Road Traffic Regulation Act 1984.

The effect of this Order will be to prohibit vehicles travelling in:

- (i) either the northbound or southbound carriageway of the trunk road from making a right hand turn from the main carriageway of the trunk road into the unnamed road giving access to Glynmil. Such vehicles should proceed via the slip roads connecting the main carriageway of the trunk road to this unnamed road; and
- (ii) a southerly direction on the trunk road from making a right hand turn into the road known as Mount View at the junction 1,300 metres north of Mountain Hare Roundabout. Such vehicles should proceed to and return via this roundabout.

These right hand turns are already prohibited by means of the Trunk Road (A4060) Merthyr Tydfil, Mid Glamorgan (Temporary

Prohibition of Right Hand Turns Order 1992) which will be revoked by the proposed Order.

A copy of this Order, a copy of the Order being revoked, together with a statement of reasons for making the Order and a plan may be introduced free of charge during normal office hours at the offices of Merthyr Tydfil Borough Council, Civic Centre, Merthyr Tydfil, Mid Glamorgan.

TOWN AND COUNTRY PLANNING ACT 1990

*The Diversion of Highways (Grovers Road, Abercynon,  
Mid Glamorgan) Order 199*

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 248 of the Town and Country Planning Act 1990 to authorise the diversion of the highway described in the Schedule to this notice in the interests of the safety of the users of the main highway, which is to be constructed in accordance with planning permission granted by Cynon Valley Borough Council on 23rd March 1990.

The proposed Order will require that the new length of highway to be provided as the diversion is to be a highway maintainable at the public expense, for which Mid Glamorgan County Council shall be the highway authority.

Within the above-mentioned period of 28 days, any person may by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting ref. ZC 510-5-5-19), object to the making of the Order.
