SCHEDULE 1

Lengths or sides of lengths of roads in Nefyn and Morfa Nefyn in the County of Gwynedd

No Waiting at Any Time, Nefyn

Pen y Bryn:

- (1) On its southerly side from its junction with the High Street to its junction with Ffordd Cae Rhyg.
- (2) On its northerly side, from its junction with Stryd y Ffynnon to a point 15 metres west of that junction.

Stryd y Plas, on its north-easterly side from its junction with Stryd y Ffynnon to a point 40 metres north-west of its junction with Stryd y Llan.

Stryd y Ffynnon, on both sides from its junction with Pen y Bryn to a point 45 metres west of that junction.

SCHEDULE 2

No Waiting at Any Time, Morfa Nefyn

1st June to 15th September

Lôn Pen Rhos:

- (1) On both sides from its junction with Lôn Terfyn to a point 40 metres north-east of that junction.
- (2) On the southerly side from a point 25 metres south-east of its junction with Lôn Tan y Mur, to a point 100 metres north-west of that junction.

Lôn Uchaf, on both sides from its junction with Lôn Terfyn to a point 30 metres south-east of that junction.

HEREFORD AND WORCESTER COUNTY COUNCIL

The County of Hereford and Worcester (James Close, Worcester) (Prohibition of Waiting) Order 1992

Notice is hereby given that Hereford and Worcester County Council propose to make an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to prohibit waiting at any time on the eastern side of James Close in the City of Worcester in the County of Hereford and Worcester from its junction with George Street for a distance of 125 metres (410 feet) in a southerly, easterly and then southerly direction including the whole of the turning head.

Exemptions in the Order will permit waiting for the purpose of:

- (a) picking-up and setting-down passengers;
- (b) loading and/or unloading goods;
- (c) delivering and collecting mail by Post Office vehicles;
- (d) delivering and collecting furniture and effects with police consent;
- (e) any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply and maintenance of any gas, electricity, water and telecommunications apparatus;
- (f) the fire brigade, ambulance or police services;

(g) the pursuance of statutory powers or duties (if no other road can be conveniently used).

An exemption in the Order also permits the waiting by disabled persons' vehicles displaying a badge issued under the Local Authority's "orange badge" scheme for a limited period of three hours, return prohibited within a further period of one hour.

Full details of these proposals are contained in the draft Order which, together with a map showing the side of length of road affected and a statement of the Council's reasons for proposing to make the Order, may be examined from Monday to Friday during normal office hours at:

HEREFORD AND WORCESTER COUNTY COUNCIL

The County of Hereford and Worcester (Old Road, Clifton-upon-Teme) (Prohibition of Driving) Order 1992

Notice is hereby given that Hereford and Worcester County Council propose to make an Order under sections 1(1) and (2), 2(1) and 2(4) of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to prohibit any vehicle from proceeding or waiting on the entire length of Old Road in the Parish of Clifton-upon-Teme in the District of Malvern Hills in the County of Hereford and Worcester.

Exemptions are contained in the Order for vehicles of the following classes or for the following purposes if the vehicle:

- (a) is being used for fire brigade, ambulance or police purposes;
- (b) is being used in any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the road, and the supply and maintenance of any gas, electricity and telecommunications apparatus;
- (c) is being used in pursuance of statutory powers or duties;
- (d) is a mechanical road cleansing vehicle;
- (e) is being used to gain access to any land or premises where there is not a satisfactory alternative means of vehicular access;
- (f) is being used for delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953;
- (g) is a pedal cycle.

The alternative route for vehicles affected by this Order is via B4204 Clifton-upon-Teme to Worcester Road.
