

## MACCLESFIELD BOROUGH COUNCIL

*Borough of Macclesfield (Hurdsfield Road, Davenport Street and Brook Street, Macclesfield) (Prohibition of Waiting) Order*

*Borough of Macclesfield (Off-street Parking Places) (Amendment of Excess Charge) Order*

Notice is hereby given that the Macclesfield Borough Council acting pursuant to arrangements made with Cheshire County Council in accordance with section 101 of the Local Government Act 1972, propose to make the above Orders in accordance with the Road Traffic Regulation Act 1984, or with the consent of Cheshire County Council.

*Borough of Macclesfield (Hurdsfield Road, Davenport Street and Brook Street, Macclesfield) (Prohibition of Waiting) Order*

The effect of the Order will be to prohibit waiting at any time on the following lengths of road:

*Hurdsfield Road:*

North side, from its junction with The Silk Road to its junction with Garden Street.

South side, from its junction with The Silk Road to its junction with Commercial Road.

*Access Road:*

*Hurdsfield Road*, both sides, from its junction with Hurdsfield Road for its full length.

*Buxton Road*, both sides, from its junction with The Silk Road to its junction with Green Street.

*Brook Street*

South side, from its junctions with The Silk Road to Allen Street and Leigh Street.

North side, for a distance of 15 metres east of its junction with The Silk Road.

*Davenport Street*, west side, from its junction with Buxton Road for its full length.

*Borough of Macclesfield (Brook Street, Macclesfield) (Prohibition of Right Hand Turns) Order*

The effect of this Order will be to prohibit the right turn from Brook Street (west side) to The Silk Road.

*Borough of Macclesfield (Various Areas 6, 7 and 8) (Prohibition of Commercial Vehicles over 7.5 Tonnes) (Weight Restriction) Order*

The effect of this Order will be to add the following areas to the ones which currently exist prohibiting heavy commercial vehicles over 7.5 tonnes except for access as follows:

*Area 6*, bounded to the west and north by a line from the junction A523/Hibel Road to a point on Queens Avenue 220 metres from its junction with Hurdsfield Road then for a distance of 130 metres along its eastern side, then to a point on Hulley Road at a distance of 280 metres from its junction with Hurdsfield Road thence via Shoresclough Brook, to the canal,

bounded to the east by the canal,  
bounded to the south by Hurdsfield Road from the canal bridge to Hibel Road.

*Area 7*, bounded to the north by Hurdsfield Road from Hibel Road to the canal bridge,  
bounded to the east by the canal,  
bounded to the south by Buxton Road from the canal bridge to The Silk Road,  
bounded to the west by The Silk Road.

*Area 8*, bounded to the north by Buxton Road from The Silk Road to the canal bridge,  
bounded to the east by the canal,  
bounded to the south by the north side of Windmill Street,  
bounded to the west by The Silk Road.

The description of Area 1 which has an eastern limit of the A523 is to be amended from the former Trunk Road to the new length of the A523 i.e. The Silk Road.

*Borough of Macclesfield (Off-street Parking Places) (Amendment of Excess Charge) Order*

The effect of this Order will be amend the excess charge provisions as follows:

Full excess charge £30, reduced to £15 is paid within 14 days or £5 if paid within 24 hours.

*Borough of Macclesfield (Chapel Street, Macclesfield) (Revocation of One-way Traffic) Order*

The effect of this Order will be to revoke the One-way Traffic Order in operation on Chapel Street.

*Borough of Macclesfield (South Grove, Alderley Edge) (Prohibition of Waiting) Order*

The effect of this Order will be to revoke the existing restriction on the east side of South Grove and prohibit waiting 8 a.m. to 6 p.m. Monday to Saturday.

*Borough of Macclesfield (Moss Lane, Alderley Edge) (Prohibition of Waiting) Order*

The effect of this Order will be to prohibit waiting at all times on the south side of Moss Lane from the termination of the existing restriction for a distance of 25 metres in a westerly direction.

*Borough of Macclesfield (The Village and New Road, Prestbury) (Prohibition of Waiting) Order*

The effect of this Order will be to prohibit waiting at any time on the following lengths of the Village and New Road:

Southern and eastern side, from its junction with Butley Lanes to a point 80 metres south of the south bank of the River Bollin.

Northern and western side, from its junction with Butley Lanes to its junction with Macclesfield Road.

*Borough of Macclesfield (Ingersley Road, Bollington) (Prohibition of Waiting) Order*

The effect of this Order will be to revoke the County of Chester (Ingersley Road and Smithy Brow Bollington Urban District) (Restriction of Waiting) Order 1973 in so far as it relates to Ingersley Road and prohibit waiting at any time on the north side of Ingersley Road from its junction with Smithy Brow for a distance of 120 metres.

Exemptions in respect of the Orders 1, 5, 6, 7 and 8 will include in respect of building or demolition operations, the loading and unloading of goods, the supply of gas, water and electricity and disabled persons vehicles.

Copies of the Orders, maps and statement of reasons may be inspected during normal office hours at the Service Centre, Town Hall, Macclesfield.

The documents in respect of Orders No. 5, 6 and 9 may be inspected at the Service Centre, Council Offices, South Drive, Wilmslow, and the documents in respect of Order No. 9 at the Service Centre, Council Offices, Knutsford, during normal office hours.

The documents may also be inspected during normal opening hours at the Public Library, Park Green, Macclesfield, in respect of Order Nos. 5, 6 and 9, at the Public Library, South Drive, Wilmslow, in respect of Order No. 9, at the Public Library, Brook Street, Knutsford, and the Public Library, Heyes Lane, Alderley Edge, in respect of Order No. 7, at the Public Library, The Village, Prestbury, and in respect of Order No. 8 at the Public Library, Palmerston Street, Bollington.
