#### CLWYD COUNTY COUNCIL

*Road Traffic Regulation Act 1984, Section 23, Proposed Site of Pedestrian Crossing B5129 Chester Road, at the Junction of Leaches Lane and Rectors Lane, Sandycroft.*

Notice is hereby given that the County Council of Clwyd in exercise of its powers under section 23 of the Road Traffic Regulation Act 1984, and after consultation with the Chief Officer of Police, proposes to establish a pedestrian crossing (pelican type) on the B5129 Chester Road at the junction of Leaches Lane and Rectors Lane, Sandycroft.

*The County Council of Clwyd (St. George Flyover to A547 Bodoryn Chapel, Abergele) (Weight Restriction) Order 199*

Notice is hereby given that the County Council of Clwyd proposes to make an Order under sections 1(1) and (2) and 2(1) to (3) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit any heavy commercial vehicle (namely any goods vehicle which has an operating weight exceeding 7.5 tonnes as defined in section 138 of the Road Traffic Regulation Act 1984) from proceeding in that length of Class III road known as Primrose Hill, St. George, from its junction with St. Asaph Road, in a northerly direction to its junction with the A547 Rhuddlan Road, opposite the property known as Bodoryn Chapel, Abergele, in the borough of Colwyn, in the county of Clwyd, except vehicles requiring access to property situated on or adjacent to that length of road.

#### COLCHESTER BOROUGH COUNCIL

*The Colchester Borough (Various Roads, Colchester) (Prohibition and Restriction of Waiting) Order No. 3, 1992*

Notice is hereby given that the Colchester Borough Council, as agents for the Essex County Council, propose to make an Order under section 1 of the Road Traffic Regulation Act 1984, the effect of which would be to prohibit waiting at all times on specified sides of the lengths of roads in Schedule 1 to this notice and to prohibit waiting between the hours of 8 a.m. and 6 p.m. Mondays to Saturdays inclusive, on specified sides of the lengths of roads in Schedule 2 to this notice. The Order will also revoke the existing restrictions in the roads specified in Schedule 1 and 2 of the Order.

Exemptions in the Order also permit the waiting of disabled persons' vehicles in accordance with the Orange badge Scheme.
