

*Cyprus Place, Rye*—Waiting limited to 2 hours in 4 hours Monday to Saturday 8 a.m. to 6 p.m. inclusive

North Side from a point 26.2 metres west of the junction with Wish Street westwards for a distance of approximately 8 metres.  
South side:

from a point approximately 55.1 metres west of the junction with Wish Street westwards for a distance of approximately 13 metres.

from a point approximately 72.9 metres west of the junction with Wish Street westwards for a distance of approximately 3.7 metres and then north for a distance of approximately 4 metres.

*The East Sussex (Roads in Guestling) (30 m.p.h. Speed Limit) Order 1992*

Notice is hereby given that East Sussex County Council have made an Order on 22nd July, coming into operation on 27th July 1992, under sections 82(2) and 83(2) of the Road Traffic Regulation Act 1984, as amended, which imposes restricted road status on certain lengths of road as listed below in the parish of Guestling.

This means that no person shall be able to drive any motor vehicle at a speed exceeding 30 m.p.h. in those lengths of road.

An exemption is included in the Order for any vehicle being used for Fire Brigade, Ambulance or Police purposes.

#### WEST SUSSEX COUNTY COUNCIL

*The County Council of West Sussex (Horsham, Various Roads) (Prohibition and Restriction of Waiting) Order 1992*

Notice is hereby given that West Sussex County Council propose to make a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to:

- (i) extend the existing prohibition of waiting at any time on both sides of Brighton Road (A281), Horsham;

#### WEST SUSSEX COUNTY COUNCIL

*The County Council of West Sussex (Haywards Heath: Oathall Road and Adjoining Roads) (Experimental Prohibition and Restriction of Waiting) (No. 2) Order 1992.*

Notice is hereby given that West Sussex County Council, under the provisions of the Road Traffic Regulation Act, 1984, propose to introduce amendments to the amended experimental order in Haywards Heath, which was brought into operation on 14th March 1992. The effect of these amendments will be to extend the prohibition of waiting at all times on:

- (a) the north-western side of Oathall Road, south-west of Sydney Road, by 65 metres in a south-westerly direction; and
- (b) the south-eastern side of the same road:
  - (i) north-east of Oathall Avenue, by 17 metres in a north-easterly direction; and
  - (ii) south-west of Sydney Road, by 21 metres in a south-westerly direction.
