

The effects of the amended order, which will be brought into operation on 1st August 1992 will be monitored and should the experiment prove to be successful, consideration will be given to making the order permanent.

A copy of the draft order, a plan showing the affected lengths of road and a statement of the County Council's reasons for proposing to make the order may be inspected at County Hall, Chichester, during normal office hours, and at the Public Library, Boltro Road, Haywards Heath, during normal library opening hours. Library staff will not be in a position to answer questions on the proposal and all enquiries should be addressed to the undersigned.
