

(b) The reference to Thirsk Road in Schedule 2 of the Order (Waiting Prohibited between the hours of 8 a.m. and 6 p.m., Monday to Saturday with Exemptions) shall be amended to:

*Thirsk Road, west side from its junction with Hatfield Road to a point 60 metres north of the centre line of Lynton Way.*

A copy of the Order which comes into operation on 29th July 1992, together with a map showing the roads affected may be examined at County Hall, Room 7, Northallerton, during normal office hours.

If you wish to question the validity of the Order or of any Provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any Instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks of 25th July 1992, make application to the High Court for the purpose.

### GRAVESEND BOROUGH COUNCIL

PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990

#### *Extension to the High Street, Gravesend Conservation Area*

Notice is hereby given that Gravesend Borough Council on 18th June 1992, pursuant to section 69 of the Planning (Listed Buildings and Conservation Areas) Act 1990, varied the boundary of the High Street, Gravesend Conservation Area to include the land and two buildings at the rear of 15 High Street which front onto Bank Street and Horn Yard.

Attention is drawn to the effect of designation of the control of demolition of buildings and to the felling, lopping, topping or damaging of trees within a Conservation Area.

Section 74 of the Planning (Listed Buildings and Conservation Areas) Act 1990, applies to all buildings in Conservation Areas other than:

- (a) Listed buildings (which are subject to control under other legislation).
- (b) "Excepted" buildings under section 75 of the Act (Churches, Chapels, ancient monuments, which are subject to control under other Regulations).
- (c) Buildings specified in a direction by the Secretary of State.

and required that any buildings to which section 74 applies shall not be demolished without the consent of the Council or of the Secretary of State.

Section 211 of the Town and Country Planning Act 1990, applies to all trees within Conservation Areas other than trees included in Tree Preservation Orders and prohibits the cutting down, lopping, topping, uprooting, wilful damage or wilful destruction of trees, except with the consent of the Local Planning Authority or where a tree is dangerous.
