TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-up of Highways (Albert Street, Canton, Cardiff, South Glamorgan) Order 1992

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up of the highway described in the Schedule to this notice to enable the development of residential properties, for which planning permission has been granted, to be carried out.

The effect of the Order will be as described in notice 481 issue number 52923 of the *London Gazette* dated 15th May 1992.

Copies of the made Order and relevant plan may be inspected during office hours at the offices of Western Permanent Housing Society Limited, 3 Radnor Court, 256 Cowbridge Road East, Cardiff, during a period of 6 weeks from 27th July 1992.

If any person desires to question the validity of the Order, or of any provisions contained therein; on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1990, or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act,

he may within 6 weeks of 27th July 1992, apply to the High Court for the suspension of quashing of the Order or of any provision contained therein.

SCHEDULE

(all distances are approximate)

The highways to be stopped-up are at Canton, Cardiff in the county of South Glamorgan. They are shown by zebra hatching on the deposited plan and lie at the northern end of Albert Street and are:

- (i) that rectangular shaped area of highway land of approximately 350 square metres which extends from a point 2 metres south-east of the northern end of the rear garden wall of number 82 Railway Terrace in an easterly direction for 25 metres and has a maximum width of 14 metres; and
- (ii) that rectangular shaped area of highway land of approximately 340 square metres which extends from the south-western corner of the grassed area which fronts number 12 Dugdale Walk in a westerly direction for a distance of 20 metres and has a maximum width of 17 metres. (482)
