SCHEDULE

Description and Boundary

Area within the City of Norwich (Conservation Area No. 20)

Commencing in the north the City Council's Conservation Area boundary passes through St. Mary's churchyard to the south of the church and proceeds in a westerly direction (following the City's constitutional boundary) until it meets the western bank of the Wensum. From here the boundary turns southwards and follows the western bank of the River Tud and River Wensum until it reaches Hellesdon Bridge. It then follows the southern side of Hellesdon Road in a south-westerly direction until approximately 10 metres beyond the entrance to Marriott Way footpath. The boundary then runs in a south-easterly direction parallel to the footpath and then turns northwards 15 metres beyond the eastern bank of the River Wensum. The boundary follows parallel to the River Wensum upstream before turning north-eastwards to run parallel to Hellesdon Road, approximately 25 metres away. At No. 152 Hellesdon Road the boundary crosses the road and turns in a northwesterly direction to follow the south-eastern boundary of No. 159 Hellesdon Road; it then turns northwards following the rear eastern boundary of Nos. 14 and 18 Hellesdon Mill Lane and the eastern boundary of Hellesdon House. At the point where this meets the rear southern boundary of No. 30 Hellesdon Mill Lane, it proceeds in a north-easterly direction following the southern and eastern boundaries of No. 30 and the southern boundary of No. 195 Hellesdon Road.

The boundary crosses Hellesdon Road and follows the western and the southern boundaries of Nos. 1-4 Hellesdon Hall Road. It then proceeds southwards following the western boundary of Hill House farmyard and stable before turning eastwards following the southern boundary of the farm complex and proceeding northwards to follow the eastern boundary to Hellesdon Hall Road adjacent to No. 30.

Crossing Hellesdon Hall Road the boundary runs in a westerly direction following the bank pavement line to the junction with Rosary Court. Here it turns northwards to follow the eastern boundary of Rotary Court. At the churchyard it follows the southern boundary in an easterly direction where it then turns northwards to follow the eastern boundary until it meets the City's constitutional boundary.

Area within Broadland District

The Broadland District Council's Conservation Area Boundary follows the western boundary of St. Mary's Churchyard northwards from the constitutional boundary of the District of Broadland to the north-western corner of that Churchyard. From there, it follows the northern and then the western boundaries of that Churchyard until it reaches the extension of the line which forms the southern boundaries of No. 3 Riverside Close, Leeside and Windlass. It then travels westwards along that line following the southern boundaries of those properties. It continues along the northern boundary of Nos. 1 to 5 Mill Cottages, following the boundary of 1 Mill Cottages for a short distance southwards to rejoin the constitutional boundary of Broadland District. It then follows that boundary eastwards to the western boundary of St. Mary's Churchyard.
