

DYFED COUNTY COUNCIL

The County of Dyfed (Unclassified Road Known as Tremeyrick Lane, Pembroke Dock) (Prohibition of Driving) Order 1992

Notice is hereby given that the Dyfed County Council propose to make an Order under sections 1(1) and (2), 2(1) to (3) and 3(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The effect of this Order will be to prohibit any motor vehicle from proceeding along that length of the unclassified road known as Tremeyrick Lane, Pembroke Dock from its junction with Arthur Street to its junction with Tremeyrick Street.

Exceptions will be provided in the Order to permit vehicles to use the said length of road for:

1. Conveying persons, goods or merchandise to or from premises or land adjacent to the said length of road.
2. Building operations, road repair or other similar works.
3. Fire Brigade, Police or Ambulance purposes.

Full details of this proposal are contained in the draft Order which together with a map showing the length of road affected and a statement of the Council's reasons for proposing to make the Order, may be inspected at the offices of Dyfed County Council at County Hall, Carmarthen, and at the offices of South Pembrokeshire District Council, at Llanion Park, Pembroke Dock, during normal office hours.

If you wish to object to the proposed Order you should send the grounds for your objection in writing to the undersigned by 21st August 1992.

DYFED COUNTY COUNCIL

The County of Dyfed (Gordon Street (East) Pembroke Dock) (One-way Traffic) (Revocation) Order 1992

Notice is hereby given that on 27th July 1992, the Dyfed County Council made an Order under sections 1(1) and (2) and 2(1) to (3) of the Road Traffic Regulation Act 1984 ("the Act"). The effect of the Order is to revoke the County of Dyfed (Gordon Street [East] Pembroke Dock) (One-way Traffic) Order 1983, thereby reverting the flow of traffic along that length of Gordon Street East from its junction with the cul-de-sac at the rear of numbers 6-18 Water Street to the junction with Water Street to a two-way flow.

The Order will come into operation on 5th August 1992, and a copy of the Order, together with a map showing the roads affected may be inspected at the offices of the Dyfed County Council, County Hall, Carmarthen, during normal office hours. Any person who desires to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Act or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, apply to the High Court for this purpose.
