The City of Gloucester (Tredworth Road) (Waiting Regulation) Consolidation and Amendment) Order 1992

Notice is hereby given that the Gloucester City Council, exercising the undermentioned powers of the Gloucestershire County Council under arrangements made pursuant to section 101 of the Local Government Act 1972, propose to make an Order under sections 1(1), 2(1), (2) and 4(2) of the Road Traffic Regulation Act 1984.
