Notice of Deposit of Proposals for the Alteration of a Structure Plan ESSEX STRUCTURE PLAN—SECOND ALTERATION

Notice is hereby given that Essex County Council has prepared proposals for the alteration of the above plan.

NEWCASTLE-UPON-TYNE CITY COUNCIL

PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990

Extension to Jesmond Dene Conservation Area

Notice is hereby given that the City of Newcastle-upon-Tyne in pursuance of the powers conferred upon them by sections 69 and 70 of the Planning (Listed Buildings and Conservation Areas) Act 1990 have extended the boundary of the Jesmond Dene Conservation Area designated by the Council in February 1992.

The boundaries of the Conservation Area have been extended to include Castles Farm Playing Fields (including Paddy Freeman's Recreation Ground), The Grove, Jesmond Gardens, Fenwick Terrace, Collingwood Terrace and parts of Castle Dene and St. Peter's Schools.

The Council considers the area to be of special interest, the character and appearance of which it is desirable to preserve and enhance and future development in this area will therefore be subject to strict planning controls designed to secure the preservation of its character and general improvement. Subject to certain exemptions, demolition of buildings within the area covered by the extension will now require the approval of the Council. Furthermore by virtue of section 211 of the Town and Country Planning Act 1990, the Council are required to be given 6 weeks notice of any proposal to cut down, top, lop, uproot, wilfully damage or wilfully destroy any tree in a Conservation Area.
