The County Council of Surrey (Parking Places and Restriction of Waiting and Loading) (Guildford) (Amendment) Order 199

Notice is hereby given that Surrey County Council propose to make an Order under sections 1, 2 and 4 of and Part III of Schedule 9 to the Road Traffic Regulation Act 1984, the effect of which will be as follows:

- (a) The removal of the "No Waiting at Any Time" restriction (double yellow lines) on the north-western side of the High Street, Guildford from the boundary between Nos. 73 and 75 High Street, to the prolongation of the boundary between Nos. 80-82 and 84-86 High Street (a distance of approximately 60 metres).
- (b) The introduction of a "No Waiting between 8.30 a.m. and 6 p.m., on Mondays to Saturdays (inclusive)" restriction (single yellow line) on the above-mentioned length of the High Street.

These proposals were introduced on an experimental basis on 20th December 1991, for a period of 18 months. It is the intention of

the Highway Authority to make a permanent Order in like terms. Reason: The Order is required as part of Guildford Borough Council's Town Centre environmetal improvements to facilitate vehicular access to the Angel Hotel.

The County of Council of Surrey (Parking Places and Restriction of Waiting and Loading) (Guildford) (Amendment) (No. 5) Order 1002

Notice is hereby given that, on 29th July 1992, Surrey County Council made an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984, the effect of which is as follows:

- (a) the introduction of "No Waiting at Any Time" restrictions (double yellow lines) in those lengths of Millmead, Guildford which are currently subject to "No Waiting Between the Hours of 8.30 a.m. and 6 p.m., Mondays to Saturdays, inclusive" (single yellow line)-this will effectively mean that, subject to (b) below, the whole of Millmead will be subject to "No Waiting at Any Time" restrictions; and
- (b) the clarification of the parking places in Millmead as follows: Parking Places with waiting limited to two hours between 8.30 a.m. and 6.30 p.m., Mondays to Saturdays (inclusive) with no return within one hour, the central area of the carriageway of Millmead which extends southwards from a point 157 metres south of the junction with High Street for a distance of 91.4 metres to a point 5.7 metres north of the southern end of that carriageway and which has a maximum width of 8.5 metres. (All vehicles to be parked diagonally to the centre line of the carriageway and wholly within the marked bays.)

These proposals were previously published as a public notice in the London Gazette, on 22nd May 1992, and the effect of the Order is as described in that notice. The Order will come into effect on Friday, 31st July 1992.

Reason: In relation to (a) above, the Order has been made to maintain access at all times to premises in Millmead for emergency service vehicles. In relation to (b) above, the Order has been made to facilitate the enforcement by Surrey Constabulary and their Traffic Wardens of the two hour restricted parking.

Note: A copy of the Order, together with a plan showing the road to which the Order relates, may be inspected between the hours of 9 a.m. and 4.30 p.m., Mondays to Fridays, at the office of the Clerk and Solicitor, Guildford Borough Council, Millmead House, Millmead, Guildford.

Any person wishing to question the validity of the Order, or of any of its provisions, on the ground that it is not within the powers of the relevant enabling Act, or that a requirement of any such enabling Act, or of any relevant regulation made thereunder has not been complied with may, within 6 weeks from 29th July 1992, make application for the purpose to the High Court.

The Surrey County Council Mint Street (D5421), Godalming (Revocation of One-way Traffic and One-way Traffic and Prohibition of Traffic) Order 1992.

Notice is hereby given that on 29th July 1992 the Surrey County Council ("the Council") made, with modifications, the above-mentioned Order under sections 1(1) and (2) and 2(1) to (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), Regulation 25 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1989, and of all other enabling powers, the effect of which is as described in subparagraphs (B) and (E) (in so far as those sub-paragraphs relate to Mint Street, Godalming) of the notice (hereinafter referred to as "the London Gazette notice") (Reference No. 537) which appeared in the edition of the London Gazette dated Friday, 20th December 1991, the issue Number of which was 52751.

The only modifications are that:

- (a) vehicles will only be prohibited from entering or proceeding in that length of the carriageway of Mint Street, Godalming which extends from the south-western kerb-line of Station Road, Godalming south-westwards for a distance of 3 metres; and
- (b) to restore a two-way system for vehicular traffic in that length of Mint Street, Godalming which extends from a point 3 metres south-west of the south-western kerb-line of Station Road. Godalming south-westwards to the northern kerb-line of Mill Lane and not to prohibit all vehicles from entering or proceeding in that length of Mint Street, Godalming.

A copy of the Order, which will come into operation on 8th October 1992, of the Surrey County Council (Mint Street, Godalming) Traffic Regulation Order 1955, of the Surrey County Council (Mint Street, Godalming) Temporary Traffic Management Measures Order 1991 and of a plan showing the lengths of road to which the Order relates, may be examined, free of charge, at the Council's Legal Information Centre (Room 122), County Hall, Penrhyn Road, Kingston-upon-Thames between 10 a.m. and 4 p.m. from Mondays to Fridays inclusive, and for a period of 6 weeks from 31st July 1992 at Waverley Borough Council Offices, The Burys, Godalming during normal office hours from Mondays to Fridays, and at Godalming Branch Library, Bridge Street, Godalming during normal opening hours.

Any person wishing to question the validity of the Order, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, may, within 6 weeks from the date of the Order, apply to the High Court for this purpose.

The previously advertised proposals referred to in sub-paragraph (a), (c), (d) and (e) of the London Gazette notice (in so far as those sub-paragraphs do not relate to Mint Street, Godalming) have now been provided for by the making on 29th April 1992, of the Surrey County Council Church Street, High Street, Lower South Street, Queen Street, South Street, and the un-named access road on the north-east side of the Pepper Pot Island Site, Godalming (Revocation of One-way Traffic and One-way Traffic and Prohibition of Traffic and Compulsory Right-hand Turn) Order 1992, which came into operation on 2nd May 1992, 13th May 1992, 7th July 1992 and 15th July 1992.
