#### PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

#### Notice of the issue of a submarine pipe-line works authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held until first oil date by Shell U.K. Limited, whose address is Shell-Mex House, Strand, London WC2R 0DX and after first oil date by Enterprise Oil plc, whose address is Grand Buildings, Trafalgar Square, London WC2N 5EJ, for the construction of a 20 inch pipe-line between the Nelson Platform and the Unity Riser Platform.

Except with the consent of the Secretary of State, the pipe-line shall only be used to convey crude oil, produced water, hydrocarbon condensates and corrosion inhibitor.
