

LONDON BOROUGH OF ISLINGTON

Disabled Persons' Parking Places

Notice is hereby given that the Islington Borough Council proposes to make the Islington (Free Parking Places) (Disabled Persons) (No. 5) Order 1992 under section 6 of the Road Traffic Regulation Act 1984.

2. The general effect of the Order will be to:

- (a) *revoke* the present Disabled Person's Parking Places in Highbury New Park, the west side, from a point 3.1 metres south of the northernmost wall of 169-191 Highbury New Park, southward for a distance of 5.5 metres.
and Halton Road, the south-west side, from a point 9.6 metres north-west of a point opposite the north-western kerb-line of Canonbury Villas, north-westwards for a distance 5.5 metres.
- (b) *designate* parking places in Arran Walk, Biddestone Road, Drayton Park, Freegrove Road, Halton Road, Poets Road, Tremlett Grove.
- (c) provide that the parking places will operate between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
- (d) specify, in respect of the parking places, that a disabled person's vehicle displaying, in the relevant position, a disabled person's badge (commonly referred to as 'the Orange Badge') issued by any Local Authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or 1982 may be left therein; and
- (e) provide that certain vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.

3. A copy of the Order, of the Islington (Free Parking Places) (Disabled Persons) (No. 1) Order 1980, (and of the Orders which have amended or applied that Order) and of the Council's statement of reasons for making the Order, and of maps which indicate the lengths of roads to which the Order relates can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 21 days from the date of this notice at the following location:

Additions to Schedule 3 of the Islington (Parking Places) (No. 1 Order) 1976

465. *Studd Street*, the east side, from a point 2 metres north of the party wall of numbers 11 and 12 Studd Street to a point 1.5 metres south of the southernmost wall of number 2 Studd Street.

466. *Halton Road*, the south-west side, from a point 15.1 metres north-west of a point opposite the north-western kerb-line of Canonbury Villas, to a point 28 metres south-east of the south-eastern kerb-line of Richmond Grove.

Additions to Schedule 2 of the Islington (Parking Places) (No. 2) Order 1970

186(A) *Bromfield Street*, the south side, from a point 35 metres east of the eastern kerb-line of Liverpool Road to a point opposite the party wall of numbers 18 and 19 Bromfield Street.

186(B) *Bromfield Street*, the south side, from a point 5.5 metres east of a point opposite the party wall of numbers 18 and 19 Bromfield Street to a point 18.9 metres west of the north-western kerb-line of Parkfield Street.

The London Borough of Merton (Off-street Parking Places) (Amendment No.) Traffic Order 1992

2.
