

WOKING BOROUGH COUNCIL

Woking Borough Council (Various Roads) (Prohibition and Restriction of Waiting) Amendment Order No. 3, 1992

Notice is hereby given that Woking Borough Council on behalf of the County Council of Surrey, pursuant to arrangements entered into under section 101 of the Local Government Act 1972, propose to make an Order under the Road Traffic Regulation Act 1984.

The effect of the Order is to amend the Woking Borough Council (Various Roads) (Prohibition and Restriction of Waiting) Order 1992 by:

- (i) prohibiting waiting at any time in the lengths of road specified in Schedule A; and
- (ii) restricting waiting between the hours of 8.30 a.m. and 6 p.m. (Monday to Friday) in the lengths of road specified in Schedule B.

Exemptions are provided in the Order to permit vehicles to wait in order to pick up and put down passengers, to load and unload goods (unless specifically prohibited), to carry out essential services or when used by local authorities in pursuance of statutory powers or duties, for a disabled persons vehicle which displays in the relevant position a disabled persons badge and parking disc, and for furniture removals.

A copy of the Order and relevant maps, together with the statement of reasons for proposing to make the Order and Order to be amended, may be examined at the Car Parks Enquiry Desk, 1st Floor, Civic Offices, Gloucester Square, Woking on weekdays during normal office hours.

If you wish to object to the Order you should send the grounds for your objection in writing to the undersigned by 26th October 1992.

No Waiting at any time

1. *Claremont Avenue*, Woking, both sides, from its junction with Guildford Road to its junction with Poplar Grove.
2. *Goldsworth Road*, south side, from a point opposite the western boundary of No. 49 Goldsworth Road to a point 40 metres west of its junction with Victoria Way.

SCHEDULE B

No Waiting between 8.30 a.m. and 6 p.m.

Chobham Road/Kettlewell Hill (A3046), both sides, from a point 15 metres north-west of its junction with Brewery Road to a point 106 metres north of its junction with Heathlands Close.

Woking Borough Council (Off-Street Parking Places) (Pay and Display) Amendment Order No. 24, 1992

Notice is hereby given that Woking Borough Council, with the consent of the County Council of Surrey, propose to make an Order under section 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order is to amend the Woking Borough Council (Off-Street Parking Places) (Pay and Display) Order 1978 by the introduction of a charge for parking between four and ten hours at Heathside, Woking, of £5.50 on Monday to Friday (excluding Bank Holidays) between 8 a.m. and 6 p.m.

The Order will also revoke the Woking Borough Council (Board School Road, Woking) (Off-Street Parking Place) Order 1992.

The classes of vehicles which may use the car park and the maximum period which they may wait are unaltered.

A copy of the Order, together with the statement of reasons for proposing to make the Order and Orders to be amended and revoked may be examined during normal office hours at the main reception area, Civic Offices, Gloucester Square, Woking.

WOKINGHAM DISTRICT COUNCIL

The Wokingham (Off-street Parking Places) (Variation No. 1) Order 1992

Notice is hereby given that the Wokingham District Council proposes to make a Variation Order under section 35 of the Road Traffic Regulation Act 1984 and all other enabling powers.

The Order will come into operation as soon as possible and will provide for the following:

- (1) *Winnersh Triangle Railway Station Car Park*—the introduction of a half day charge of 30p for up to 4 hours.
- (2) *Carnival Pool Car Park, Wellington Road, Wokingham*—the inclusion of this car park in the Wokingham (Off-Street Parking Places) Order 1986. The charges which will operate on Mondays to Saturdays 8 a.m. to 6 p.m. are 20p for up to half an hour; 40p for up to 1 hour; 60p for up to 2 hours and 90p for up to 3 hours (maximum). Sunday all day and Monday to Saturday between 6 p.m. and 8 a.m.—no charge. Use is restricted to vehicles whose unladen weight does not exceed 30 cwt.

The charges will operate on the days and times specified in the Schedule to the Order.

The car parks will be regulated by the existing Regulations contained in the Wokingham (Off Street Parking Places) Order 1986 as varied.

A copy of the proposed Variation Order and a statement of the Council's reasons for making it can be inspected at the Council Offices, Shute End, Wokingham, Berkshire on Monday to Thursday, 8.30 a.m. to 5 p.m. and Friday, 8.30 a.m. to 4 p.m. until 23rd October 1992.

Any objections to the proposed Order should be made in writing and sent to me not later than 23rd October 1992, stating the grounds on which the objection is made.

HUNTINGDONSHIRE DISTRICT COUNCIL

The District of Huntingdonshire (Tebbutts Road Car Park, St. Neots) Order 199
