Notice is hereby given that, the Chelmsford Borough Council, acting as agents of the Essex County Council, have made an Order with modifications under sections 1(1) and (2), 2(2), 4(1) and (2), 45(1) and (2) and 46(1) and (2) of the Road Traffic Regulation Act 1984 and all other powers hereby enabling.

The Order will come into effect on 1st November and introduces waiting restrictions on the roads shown in the schedules attached to the Order. Certain lengths of road will be principally for parking by permit or by ticket. Residents will initially be eligible to purchase for use on their own vehicles resident's parking permits which will expire on 30th September 1993. In addition residents may purchase at a cost of £8 one Temporary Parking Permit in any one year which lasts for 1 month. Temporary Parking Permits are for use on the vehicles of people visiting them. Residents may also purchase for their visitors Visitors' Tickets at 50 pence each to enable them to park for a maximum of 4 hours. The charge for parking without a Permit or Visitors Ticket will be £36 per day with a discounted charge for payment within 7 days of £18.

Residents of the Zone who are aged 65 or over will be eligible for one free residents permit or one free visitors permit per household. Permits and tickets will be sold in advance of the scheme coming into effect in the General Office (Room 32), Administration Department, Civic Centre, Chelmsford from 19th October 1992.

The Order contains provisions which would allow for the issue of permits for "business" parking. It is not currently intended to issue any such permits and before any were issued the proposed charges would be advertised.

A copy of the Order giving full details of the scheme and a map showing the area affected are available in the Administration Department, Civic Centre, Duke Street, Chelmsford, and the Local Government Library (E Block) County Hall, Chelmsford where they may be inspected during normal office hours.

The Notice of proposal to make the above-mentioned Order was published in The London Gazette of 14th August 1992 (Issue No. 53020, page 13817, entry 530). The effect of the Order is as described in that Notice, except that the scheme will not include Saturdays and will now relate only to Monday to Fridays and exclude parking areas in Cramphorn Walk.
