The County of Durham (C186 Picktree Lane and unclassified Bonemill Lane, Rickleton, Chester-Le-Street) (40 m.p.h. Speed Limit) Order 1992.

The effect of the Order will be to introduce a 40 m.p.h. speed limit on the following roads:
