

(b) Kingslake Street, between Old Kent Road and a point 7 metres south-west of the south-western wall of Swanley House; and in

(c) Dunton Road, between Old Kent Road and a point 59 metres north-east of Old Kent Road.

(iii) New one-way working for vehicular traffic will be imposed in Rolls Road between Rowcross Street and Humphrey Street, traffic moving in a north-westerly direction.

4. The Box Junction in Old Kent Road at its junction with Dunton Road will be removed.

5. *Compulsory Left Turns:*

(i) There will be new compulsory left turns for vehicles proceeding from the roads listed in column 1 of the table below into the roads listed in column 2 below.

Mina Road	Old Kent Road
Old Kent Road (the north-west side of the triangular island site to be constructed)	Dunton Road
Access road leading to No. 302 Old Kent Road.	Old Kent Road
Humphrey Street (from the south-east side of the triangular island site to be constructed)	Old Kent Road

(ii) Compulsory left turns from Coopers Road, Cobourg Road, Trafalgar Avenue and Rowcross Street into Old Kent Road will also continue to be imposed.

6. A compulsory right turn will be imposed for vehicles travelling in a north-westerly direction in Old Kent Road from the eastern side only of an island site to be constructed at its junction with Dunton Road into Dunton Road.

7. *Compulsory Ahead Only:*

(i) Vehicles travelling in the direction and the part of the roads specified below will have to continue ahead in the same direction on reaching the junctions with Dunton Road.

(a) Old Kent Road, in a south-easterly direction (for vehicles positioned only between the north-east side and south-west side of an island site to be constructed).

(b) Old Kent Road in a north-westerly direction (for vehicles positioned only on the south-west side of an island site to be constructed); and

(c) Mandela Way, in a south-easterly direction (for vehicles positioned in any part of the south-east bound carriageway).

8. *No-right Turns:*

(i) There will be new no-right turns for vehicles from the roads listed in column 1 in the table below into the roads listed in column 2.

Old Kent Road	Access Road leading to No. 302 Old Kent Road
Dunton Road	Mandela Way (the north-western arm)
Mandela Way (the south-eastern arm)	Dunton Road.

(ii) Right turns from Old Kent Road into Kingslake Street, Mina Road, Albany Road (Except buses) and Humphrey Street will continue to be prohibited.

9. *No-left Turns:*

(i) There will be no left turns for vehicles from the roads listed in column 1 in the table below into the roads listed in column 2.

Humphrey Street (from the north-western side of the triangular island side)	Old Kent Road

10. Exemptions will be provided in the Order in respect of anything done:

(a) with the permission or at the direction of a police constable in uniform;

(b) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

11. A copy of the Order which will come into operation on 5th October 1992 and of the Orders which have been amended by the Order together with plans can be inspected during normal hours on Mondays to Fridays inclusive until the end of 6 weeks from the date on which the Orders were made, in the Municipal Offices, Larcom Street SE17 1RY and the Information Centre, Town Hall, Peckham SE5 8UB.

12. Copies of the Order may be obtained from the Municipal Offices, Larcom Street SE17 1RY.

13. Any person desiring to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

SCHEDULE 1

Albany Road, between a point 15 metres west of the western wall of No. 140 Albany Road and its junction with Old Kent Road.

Dunton Road:

The north-west side, between a point 14 metres north-east of its junction with Old Kent Road and the south-western kerb-line of Willow Walk.

The south-east side, between a point opposite the south-western kerb-line of Marcia Road and a point 27.43 metres south-west of the south-western kerb-line of Lynton Road.

Old Kent Road, the north-east side, between a point opposite the north-western kerb-line of Coopers Road and a point opposite the north-western wall of No. 357 Old Kent Road.

SCHEDULE 2

Dunton Road:

The north-west side, between its junction with Old Kent Road and point 14 metres north-east of that junction.

The south-eastern side, between its junction with the Old Kent Road and a point opposite the south-western kerb-line of Marcia Road.

Humphrey Street, between the north-eastern kerb-line of Old Kent Road and a point 55 metres north-east of that kerb-line.

Old Kent Road, north-east side, between a point opposite the north-western wall of No. 357 Old Kent Road and a point opposite the party wall of Nos. 275 and 275A Old Kent Road.

SCHEDULE 3

Dunton Road, the north-west side, between a point 14 metres north-east of the north-eastern kerb-line of Old Kent Road and a point 20 metres north-east of the north-eastern kerb-line of Marcia Road.

Old Kent Road, the north-east side, between a point opposite the north-western wall of No. 357 Old Kent Road and a point 17 metres south-east of the south-eastern kerb-line of Rowcross Street.

SCHEDULE 4

Albany Road, between the south-western kerb-line of Old Kent Road and a point 21.34 metres south-west of that kerb-line.

Dunton Road, the north-west side, between the north-eastern kerb-line of Old Kent Road and a point 14 metres north-east of that kerb-line.

Old Kent Road:

The north-east side, between a point opposite the party wall of No. 275 and 275A Old Kent Road and its junction with the north-western kerb-line of Dunton Road; and

Between a point 17 metres south-east of the south-eastern kerb-line of Rowcross Street to the north-western kerb-line of Coopers Road.

SCHEDULE 5

Dunton Road, the south-east side, between the north-eastern kerb-line of Old Kent Road and a point opposite the south-western kerb-line of Marcia Road.

Humphrey Street, between the north-eastern kerb-line of Old Kent Road and a point 55 metres north-east of that kerb-line.
