The intention of the above Order is to introduce waiting restrictions on Leyland Road and Talbot Road, Lower Penwortham. The restrictions on Talbot Road, will be on both sides from Leyland Road, eastwards to the entrance of No. 41 Leyland Road.

The whole length of Leyland Road, from No. 9 to Swallow Avenue, will be no parking at any time, on any day, except for both sides of the road between the dismantled railway line, to outside No. 31 Leyland Road, from the Royal British Legion Club, to outside No. 61 and, from the boundary of Nos. 62-64 to outside No. 54, Leyland Road.

Due to a number of accidents involving pedestrians, the Council has produced a remedial scheme consisting of four pedestrian refuges. At these locations the lane width will be reduced to a minimum 3.4 metres and also, taking into consideration the residential nature of the road, it is proposed to introduce waiting restrictions, prohibiting waiting at any time on any day. Thus ensuring that the carriageway is left clear of parked vehicles adjacent to the refuges thereby allowing the traffic to progress unobstructed along the road and provide areas where the visibility of pedestrians wishing to cross the road not be obscured by parked vehicles.

Notice is hereby given that the South Ribble Borough Council, pursuant to arrangements made under section 101 of the Local Government Act 1972, with the Lancashire County Council and after consultation with the Chief Officer of Police, proposes to make an Order under sections 1(1), 2, 3 and 4(2) of the Road Traffic Regulation Act 1984.

There are problems of indiscriminate parking of vehicles on Ward Street, especially where the road bends near to Cuerden Green Mill, and close to the junction with Watkin Lane. Also obstructions are being caused by vehicles being parked opposite each other at various points along the street. ROCHESTER UPON MEDWAY CITY COUNCIL
