Notice of seizure under the Customs and Excise Management Act 1979

Pursuant to section 139(6) of the Customs and Excise Management Act 1979 and paragraph 1 of Schedule 3 thereto, H.M. Commissioners of Customs and Excise hereby give notice that, by virtue of the powers contained in the Customs and Excise Acts, certain goods, namely:

- 545 cases of frozen boneless silverside beef detained at Great Harwood Cold Store, Great Harwood Food Products Ltd., Balfour Street, Great Harwood, Lancashire BB6 7SH.
- 558 cases of frozen boneless rump beef detained at Portsmouth Cold Store, Sackville Street, Southsea, Portsmouth.
- 2,002 cases of frozen boneless beef made up of 353 cases of thick flanks, 650 cases of topsides, 445 cases of rumps and 554 cases of striploins, detained at Rayleigh Cold Store, Stadium Way, Rayleigh Road, Benfleet, Essex.
- 1,206 cases of frozen boneless beef made up of 1070 cases of rumps and 136 cases of striploins detained at Tuvey's Cold Store, Sandy Lane Farm, Sandy Lane, Aveley, Essex RM15 4XL.

- 66 Cases of frozen boneless beef detained at Novacold, Leeway Industrial Estate, Newport, Gwent NP9 0QU.
- 2,970 cases of frozen boneless beef and 261 cases of frozen boneless beef detained at GS (Storage and Distribution) Ltd., Puritan Warehouse, Halton Road, Runcorn WA7 5QT.
- 235 cases of frozen boneless silverside beef detained at Excel Logistics, Nest Road, Felling Industrial Estate, Felling, Gateshead, Tyne and Wear NE10 0ES.

Have been seized as liable to forfeiture by force of the following provisions namely:

1. *Section 49(1)(e) of the Customs and Excise Management Act 1979*

The said goods having been imported were found not to correspond with the entry made in respect of them in that they were described as being of Italian origin when in fact they were of Irish origin.

2. *Section 49(1)(f) of the Customs and Excise Management Act 1979*

The said goods being imported goods were packed or concealed in a manner appearing to be intended to deceive a Customs officer in that the Irish Intervention beef had been repackaged in Italian boxes and its Irish origins had been further concealed by the attempted removal of all the Irish Intervention stamps on the meat.

2. *Section 141(1)(b) of the Customs and Excise Management Act 1979*

The said goods, or a proportion thereof, were mixed, packed or found with other goods liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in writing in accordance with paragraphs 3 and 4 of Schedule 3 to the Customs and Excise Management Act 1979.

If you are outside the United Kingdom and the Isle of Man you must also give the name and address of a Solicitor in the United Kingdom who is authorised to accept service of process and act on your behalf.

If you do not give notice of claim within the said period of one month or, if any requirement of the above-mentioned paragraph 4 is not complied with, the goods in question will be deemed to have been duly condemned as forfeited.
