HIGHWAYS ACT 1980

The Raglan—Llandovery Trunk Road (A40) (Improvement at Glangrwyney Bridge, Side Roads) Order 1992

The Secretary of State for Wales hereby gives notice that in relation to the above-mentioned Trunk Road at Glangrwyney in the County of Powys he has made under sections 14 and 125 of the Highways Act 1980, an Order which will authorise him:

- 1. to stop up a highway,
- 2. to stop up private means of access to premises (for the duration of the Construction Works only), and
- 3. to provide new means of access to premises,

all at Glangrwyney, aforesaid.

Copies of the Order and the relevant plan have been deposited at the offices of Powys County Council, Area Office, The Watton, Brecon; Borough of Brecknock, Council Offices Beaufort Chambers, Crickhowell; and the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff, where they are open to inspection, free of charge, at all reasonable hours.

Copies of the Order, the title of which is The Raglan—Llandovery Trunk Road (A40) (Improvement at Glangrwyney Bridge, Side Roads) Order 1992 can be obtained from the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff.

Any person aggrieved by the Order, and desiring to question the validity thereof or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1980, or on the ground that any requirement of that Act or of regulations made thereunder has not been complied with in relation to the Order, may within 6 weeks from 8th October 1992 or within 6 weeks from the date of publication of this notice if such period shall expire later, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
