To amend the charges and charging periods in the city centre car parks as follow:

- (1) "Blue Code" and "Green Code" will merge to form a new "Short Stay" code. The charges will be 40p for 1 hour, 80p for 2 hours, with a maximum stay of 2 hours.
- (2) Charlotte Place car park will remain open all the time, instead of opening at 8.30 a.m. Parking before 9 a.m. will cost £5 regardless of how long you intend to stay, but lower charges as in (3) below will apply after 9 a.m.
- (3) "Orange Code" and "Yellow" charges will be merged to form a new "General Purposes and Long Stay" code. The charges will be 40p for 1½ hours, 80p for 3 hours, £2 for 5 hours, £3 for over 5 hours, for Monday to Friday. On Saturdays, these charges will be 30p for 2 hours, 40p for 3 hours, 80p for 4 hours, £2 for 5 hours, £3 for over 5 hours.
- (4) Marlands car park will cost 30p for 2 hours, 40p for 3 hours, 80p for 4 hours, £2 for 5 hours, £5 for over 5 hours, Monday to Saturday.
- (5) St. Mary Street south car park will cost 40p for 1½ hours, 80p for 3 hours, £2 for 5 hours, £3 for over 5 hours, on Mondays, Tuesdays and Wednesdays. For Thursdays, Fridays and Saturdays, when Kingsland Market is in operation the charges will be 30p for 1 hour, 60p for 2 hours with 2 hours maximum stay.
- (6) Charges and charging periods at Mayflower Park will not be changed.
- (7) Season tickets will now be available on a monthly basis as well as the previous 12, 6 or 3 month periods.
- (8) Cheaper "contract" season tickets for selected car parks will be introduced for 1, 3, 6 and 12 month periods.
- (9) Parking charges will be introduced at the Saturday rate on Bank Holidays.
