

## SEVENOAKS DISTRICT COUNCIL

## PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990

*Conservation Area—Riverhead*

Notice is hereby given, in pursuance of section 69 of the Planning (Listed Buildings and Conservation Areas) Act 1990, that the Sevenoaks District Council have determined that the area described in the Schedule to this Notice is an Area of Special Architectural or Historic Interest the character or appearance of which it is desirable to preserve or enhance and have accordingly designated the said area as an extension to the Riverhead Conservation Area.

The effect of the designation of a Conservation Area may be summarised as follows:

- (a) Where any application for planning permission for development of land in or adjacent to the Conservation Area is made to the Council and the development would, in the opinion of the Council, affect the character or appearance of the Conservation Area, the application will be subject to the special procedure in section 67 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
- (b) Anyone wishing to demolish a building or a part of a building situated within the Conservation Area must first apply for consent to demolition to the Local Planning Authority. This is not taken to be included in a planning permission unless, in granting the planning permission, the Authority states that it includes consent to demolish the building.
- (c) Anyone wishing to cut down, top, lop or uproot a tree situated within the Conservation Area must give 6 weeks prior notice of his intention to the Local Planning Authority.

A plan showing the land included in the extension of the Conservation Area may be inspected free of charge during normal office hours at the Council Offices, Argyle Road, Sevenoaks.

*The Northamptonshire County Council (A605 Warmington By-pass and Tansor Improvement Classified Road) (Side Roads) Order 1992.*

The Northamptonshire County Council of County Hall, George Row, Northampton NN1 1DN, hereby give notice that they have made, and submitted to the Secretary of State for Transport for confirmation, an Order under sections 14 and 125 of the Highways Act 1980 for authorising the Council:

- (a) to improve, raise, lower or otherwise alter highways;
- (b) to stop-up highways;
- (c) to construct new highways;
- (d) to stop-up private means of access to premises;
- (e) to provide new means of access to premises;

all on or in the vicinity of the route of the Northampton to Peterborough Principal Road A605 which the Council propose to improve and the two lengths of classified road which the Council propose to construct firstly from a point on the A605 Principal Road 830 metres south-west of Tansor Crossroads to a point on the said Principal Road 110 metres north-east of Tansor Crossroads a distance of 940 metres and secondly from a point on the said Principal Road 330 metres south-west of Warmington Crossroads to a point on the said Principal Road 930 metres north-east of its junction with Buntings Lane a distance of 2,030 metres all in the Parishes of Tansor and Warmington in the District of East Northamptonshire.
