## ROAD TRAFFIC ACTS

### BARNSELY METROPOLITAN BOROUGH COUNCIL

*The Metropolitan Borough of Barnsley (Darfield Area) (Traffic Regulation Consolidation) Order 1987 (Amendment No. 2) Order 1992.*

Notice is hereby given that on 2nd October 1992, the Barnsley Metropolitan Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984 (as amended).

The effect of the Order which will come into operation on 10th October 1992, will be to prohibit any vehicle from proceeding in Cathill Road and Broomhill Lane at Darfield extending from A635 Doncaster Road to Everill Gate Lane; except for vehicles requiring access to premises situate on or adjacent to the roads.
