Notice is hereby given that an application is being made to the National Rivers Authority by P. T. Fillery & Sons, of The Oaks, Tenbury Wells, Worcestershire WR158TH, to vary licences serial Nos. 18/54/9/480 and 18/54/9/487 to abstract water from The Ledwyche Brook.

At present licence No. 18/54/9/480 authorises abstraction from the Ledwyche Brook between SO 5637 7054 and SO 5667 6986 at Bleathwood, Tenbury Wells and licence No. 18/54/9/487 authorises abstraction from the River Teme between SO 6851 6817 and SO 6904 6760 at Puddleford Farm, Eastham, Worcestershire. Both licences are for 22,730 cubic metres to be abstracted at 82 cubic metres per hour during the period March to October inclusive for spray irrigation purposes. The Ledwyche Brook enters the River Teme upstream of Puddleford Farm.

The variations applied for are: On 18/54/9/480 to be able to take an additional 45,470 cubic metres during the period November to March inclusive at a rate of 50 cubic metres per hour and to delete the month of March from the existing summer period. The additional water will be stored in reservoirs for subsequent spray irrigation direct and/or release into the Ledwyche Brook for reabstraction downstream on licence No. 18/54/9/487. On 18/54/9/487 to be able to abstract from the River Teme a'ng the authorised reach maximum of 68,200 cubic metres during the existing authorised period at a rate not exceeding 154 cubic metres per hour and also to be able to abstract when the flow restriction is in force providing water is being released in similar quantities from the reservoirs created on licence No. 18/54/9/480.
