

LANCASHIRE COUNTY COUNCIL

The Lancashire County Council (St. Mary's Road, Great Eccleston, Wyre Borough) (Experimental Prohibition of Driving) Order 1992

Notice is hereby given that Lancashire County Council intend to make an Experimental Traffic Regulation Order under sections 9 and 92 of the Road Traffic Regulation Act 1984, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be to prohibit any vehicle from driving along a one metre length of St. Mary's Road, Great Eccleston at a point 37 Metres south of its junction with Barrows Lane/Pennine Way.

The prohibition is to be supported by the provision of bollards pursuant to section 92 of the Act.

This Order shall come into force on 19th October 1992 and shall remain in operation for 18 months from that date. A copy of the Order and relevant plan may be inspected at the offices of Wyre Borough Council, Wyre Civic Centre, Breck Road, Poulton-le-Fylde and at Christ Church Precinct, County Hall, Preston, during normal office hours.

WARWICK DISTRICT COUNCIL

Talisman Square, Kenilworth, Off-street Parking Places Order 1992

Notice is hereby given that the Warwick District Council propose to make an Order under the powers contained in the Road Traffic Regulation Act 1984 and the Parking Act 1989.

The general effect of the Order is to regulate and control the use of the car park at Talisman Square, Kenilworth and to introduce car parking charges as follows:

Limited stay area (four hours maximum) up to 1 hour—10p
1 to 4 hours—40p

All day parking area—80p

The charges will apply during the hours of 8 a.m. and 6 p.m. Monday to Saturday inclusive. The Order includes exemptions for disabled drivers.

Appropriate season tickets can be purchased from the Engineer and Surveyor's Department, 1 Warwick New Road, Leamington Spa, for use in the car parks in Leamington, Warwick and Kenilworth. An excess charge of £37 including vat will be levied for failure to exhibit a parking ticket on a vehicle or for leaving a vehicle in a parking place for longer than the period for which payment is made or for failing to park in a designated space: the excess charge may be reduced where payment is made of the appropriate charge and the excess charge within seven days.
