NATIONAL RIVERS AUTHORITY—SOUTHERN REGION

Notice of application for consent in pursuance of Schedule 10

Notice is hereby given in accordance with Schedule 10 of the Water Resources Act 1991, that an application has been made to the National Rivers Authority (Southern Region) by Southern Water Services Ltd., for consent to discharge to the English Channel from Shoreham Marine Treatment Works, Basin Road South, Shoreham Harbour, West Sussex.

The application proposes that:

1. There will be a discharge of up to 15,082 cubic metres per day (in dry weather conditions) of settled screened sewage effluent from a new 3,100 metre long sea outfall, at National Grid Reference TQ 2495 0160.
2. When the flow to treatment exceeds 653 litres per second and the storage capacity within the sewerage system is exceeded, there will be a discharge of screened storm sewage from the existing 500 metre sea outfall, at National Grid Reference TQ 2140 0423. Such a discharge will on average not occur more frequently than 1.5 times per bathing season.
3. In the event of an emergency, due to total power failure at the pumping station, there may be a discharge of screened sewage effluent from the 500 metre sea outfall, at National Grid

Reference TQ 2410 0423. The pumping station will have alarms, which will be connected to Southern Water Services' divisional telemetry system. Standby equipment will be provided, and up to 21,300 cubic metres of storage capacity within the sewerage system will be available to contain sewage in an emergency.

This scheme has been proposed to achieve compliance with the EC Bathing Water Directive (76/160/EEC), and to provide the level of treatment required in accordance with the ministerial statement known as the Patten Initiative.
