**Winterstoke Road:**

North-east side:

- (a) from 43 metres south-east of Longmoor Road south-eastwards for 10 metres.

## AVON COUNTY COUNCIL

*Avon County Council (Weston-super-Mare Area, District of Woodspring) (General Traffic Regulation) (Consolidation) (Variation No. 5) Order 199 .*

Notice is hereby given that the County Council of Avon proposes to make an Order under sections 1(1), 2(1) to (3), 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended, the effect of which will be:

- (a) to prohibit any vehicle entering or proceeding in that length of Lawrence Road (Western Arm) which extends from its junction with Church Road southwards for 2 metres, and
- (b) to vary the existing waiting restriction in Lawrence Road (Western Arm) as specified in the Schedule to this notice. This is a necessary consequence of item (a) above.

Full details of the proposal are contained in the draft Order, which together with a map and a statement of the Council's reasons for proposing to make the Order and a copy of the Order to be varied, may be inspected at the undermentioned offices during normal office hours (callers should report to Reception and ask for the Statutory Orders Section) and at Worle Public Library, The Maltings, Worle, Weston-super-Mare during normal opening hours.

## AVON COUNTY COUNCIL

*Avon County Council (Safe Routes to School, Eastern Zone, City of Bristol) (General Traffic Regulation) (Variation No. 1) Order 1992.*

Notice is hereby given that on 6th October 1992, the County Council of Avon made an Order under sections 1(1), 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the effect of which is to vary the County Council of Avon (Safe Routes to School, Eastern Zone, City of Bristol) (General Traffic Regulation) Order 1990 so as to revoke the provision which prohibited any vehicle proceeding in Speedwell Road to make a right hand turn into Duncombe Road. This is to be effected by providing an opening in the median strip to allow this movement only.

This Order will make permanent, without amendment, the provisions of the County Council of Avon (Safe Routes to School, Eastern Zone, City of Bristol) (Suspension of Prohibited Right Hand Turn—Speedwell Road/Duncombe Road) Experimental Order 1991, which will be revoked.

The Order will come into operation on 26th October 1992, and a copy thereof together with a map and a copy of the Order to be varied may be inspected at the undermentioned offices (callers should report to Reception and ask for the Statutory Orders Section) during normal office hours.

Any person who desires to question the validity of, or of any provision contained in the Order on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, as amended, or on the grounds that any of the relevant requirements of that Act has not been complied with in relation to the Order, may within 6 weeks after the date on which the Order was made, apply to the High Court for this purpose.
