Avon County Council (Various Roads, Stoke Gifford, District of Northavon) (Prohibition and Restriction of Waiting) Experimental Order 1992.

Notice is hereby given that on 1st October 1992, the County Council of Avon made an Order under section 9 of the Road Traffic Regulation Act 1984 as amended, the effect of which is, for a maximum period of eighteen months, to introduce specified waiting restrictions in the lengths of road specified in Part I and Part II of the Schedule to this notice.

Exemptions in the Order permit any vehicle to wait for the purpose of boarding or alighting; loading or unloading goods; Post Office services; maintenance of the road; supply of gas, water or electricity; the pursuance of statutory powers or duties; taking in petrol, oil, water or air from any garage; weddings or funerals and in accordance with the current provisions for disabled persons' vehicles. An exemption is also contained for vehicles being used for fire brigade, police or ambulance purposes in an emergency

Objections and representations to the Experimental Order continuing indefinitely, together with the grounds on which they are made, should be sent in writing to the undermentioned address quoting ref. DS/P-4-010 by 30th April 1993. The County Council of Avon will consider in due course whether the provisions contained in the Experimental Order should be continued indefinitely. At that time any objections and comments received will be given consideration. Please note that all representations received may be considered in public by the County Council and that the substance of any representation together with the name and address of the person making it could become available for public inspection. The Order will come into operation on 26th October 1992 and a

copy thereof together with a map and a statement of the Council's reasons for making the Order, may be inspected at the undermentioned offices (callers should report to Reception and ask for the Statutory Orders Section) during normal office hours and at Winterbourne Public Library, Flax Pits Lane, Winterbourne, during normal opening hours.

Any person who desires to question the validity of, or of any provision contained in the Order on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 as amended, or on the grounds that any of the relevant requirements of that Act has not been complied with in relation to the Order, may, within 6 weeks after the date on which the Order was made, apply to the High Court for this purpose.

Revision of traffic movements in the Lombard Street area

Notice is hereby given, that, the Common Council of the City of London on 9th October 1992, made the City of London (Prescribed Routes) (No. 8) Traffic Order 1992 under sections 6 and 124 of and Part IV of Schedule 9 to the above-mentioned Act of 1984, as amended.

Notice of the Common Council's intention to make the Order was first given in *The London Gazette* on 8th August 1992, page No. 12124, ref. 783 and the effect of the Order will be the same as given in that notice.

The general effect of the Order will be to:

- (a) revoke the City of London (Prescribed Routes) (City of London) Regulations 1965 and the City of London (Prescribed Routes) (No. 2) Traffic Order 1968;
- (b) revoke the City of London (Prescribed Routes) (No. 6) Traffic Order 1971 which prohibits vehicles entering Lombard Street at certain points during a specified period of the day;
- (c) re-enact without change the provisions of the Regulations and Order specified in paragraph (a) above;
- (d) make permanent the temporary one-way working for vehicles in:
 - (i) Abchurch Lane, between Lombard Street and King William Street from north-east to south-west; (ii) Lombard Street, between King William Street and
 - Abchurch Lane in a general easterly direction;
- (e) compel the left turn by vehicles from the lengths of streets specified in the Schedule to this notice into King William Street.

Exemption has been provided in the Order:

- (a) in respect of anything done with the permission or at the direction of a police constable in uniform;
- (b) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the City Police.

The proposal to ban the right turn by vehicles from King William Street into Lombard Street will be the subject of a further Order.

A copy of the Order, which will come into operation on 19th October 1992, of the above-mentioned regulations of 1965 and the above-mentioned Orders of 1968 and 1971 and of a plan showing the affected streets can be inspected during normal office hours on Mondays to Fridays inclusive, until the end of 6 weeks from the date on which the Order was made in Room 123 West, The Guildhall, London EC2P 2EJ.

Any person desiring to question the validity of the Order or of any provision contained therein on the ground that it is not within the owers of the relevant sections of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks from the date on which the Order was made, make application for the purpose to the High Court.
