THE HIGHWAYS ACT 1980

The M4 Motorway Castleton—Coryton (Connecting Roads, Special Roads) Scheme 1992

The County Council of South Glamorgan (Peripheral Distributor Road—Pentwyn Link, Classified Road) (Side Roads) Order 1992

The Secretary of State for Wales hereby gives notice that he has confirmed the following:

1. The M4 Motorway Castleton—Coryton (Connecting Roads, Special Roads) Scheme 1992 which was made under sections 16, 17 and 324 of the Highways Act 1980 and which, as confirmed, authorises the Council to provide special roads to connect the Motorway with other highways, for the exclusive use of traffic set out in Schedule 4 to the Highways Act 1980.
2. The County Council of South Glamorgan (Peripheral Distributor Road—Pentwyn Link, Classified Road) (Side Roads) Order 1992 which was made by the Council under Sections 14 and 125 of the Highways Act 1980 and which, as confirmed, authorises the Council:
 - (a) to improve, raise, lower or otherwise alter highways,
 - (b) to stop up highways,
 - (c) to construct new highways,
 - (d) to stop up private means of access to premises, and
 - (e) to provide new means of access to premises.

all on or in the vicinity of the route of the classified road which the Council are proposing to construct between the A48 Eastern Avenue and the M4 Motorway.
