## CANNOCK CHASE DISTRICT COUNCIL

CLEAN AIR ACT 1956

Cannock Chase District Council (Rugeley No. 2) Smoke Control Order 1993

Notice is hereby given that the Cannock Chase District Council in exercise of the powers conferred on them by section 11 of the above mentioned Act propose to make an Order entitled the Cannock Chase District Council (Rugeley No. 2) Smoke Control Order 1993 declaring the area described in the Schedule hereto to be a Smoke Control Order.

Subject to the limitations and exemptions provided by the Order and by virtue of section 11(2) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding level 3 on the standard scale which is currently £1,000 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity. It is intended that the Order will become operative on 1st October 1993.
