LANCASHIRE COUNTY COUNCIL

The Lancashire County Council (Various Roads, West Lancashire District) (Prohibition of Driving) Order 199 .

The Lancashire County Council (Various Roads, West Lancashire District) (Width Restriction and Revocation) Order 199

Notice is hereby given that the Lancashire County Council propose to make an Order under sections 1, 2 and 3 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, the effect of which will be to:

- (1) Revoke the Lancashire County Council (Various Roads, West Lancashire Rural District and Formby Urban District) (Weight Restriction) Order 1966.
- (2) Prohibit any vehicle or trailer, the width of which, inclusive of any load, exceeds 6 feet, from proceeding along the lengths of road in the Downholland and Halsall Moss Prohibition Zone, the boundary of which is specified in Schedule 1 to this notice, except for the purpose of gaining access within the Prohibition Zone.
- (3) Prohibit any vehicle or trailer, the width of which, inclusive of any load, exceeds 6 feet, from proceeding along the lengths of road in the Wyke Cop Prohibition Zone, the boundary of which is specified in Schedule 2 to this notice, except for the purpose of gaining access within the Prohibition Zone.

SCHEDULE 1

Boundary of Downholland and Halsall Moss Prohibition Zone

Point A: Where the southerly boundary of New Cut Lane meets the easterly bank of Fine Janes' Brook.

Line A-B: Follows the southerly boundary of New Cut Lane.

Point B: Where the southerly boundary of New Cut Lane meets the westerly abutment of the bridge over the former railway track.

Line B-C: Follows a straight line between points B and C.

Point C: Where the centre line of Carr Moss Lane meets the centre line of a ditch approximately 17 metres west of the vehicular entrance to The Willows.

Line C-D: Follows a straight line between points C and D.

Point D: On the centre line of Plex Moss Lane approximately 30 metres west of the centre line of the access road to Park House Farm.

Line D-E: Follows a straight line between points D and E.

Point E: On the centre line of Station Road approximately 165 metres west of the centre line of Shaw Lane.

Line E-F: Follows a straight line between points E and F.

Point F: On the centre line of Old Moss Lane approximately 12 metres north-west of the centre line of Riding Lane.

Line F-G: Follows a straight line between points F and G.

Point G: Where the westerly bank of the Cheshire Lines Brook meets the centre line of the New Cut ditch.

Line G-H: Follows the centre line of the New Cut ditch.

Point H: Where the centre line of the New Cut ditch meets the easterly bank of Downholland Brook.

Line H-I: Follows the easterly bank of Downholland Brook.
