Notice is hereby given that Dacorum Borough Council, pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Hertfordshire in exercise of the powers of the said County Council under sections 1(1) and (2), 2(1) to (3), 3(2), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act intend to make an Order which will have the following effect:

## (1) To revoke:

The Fourth Schedule to the Borough of Hemel Hempstead (Traffic Regulation No. 1) Order 1963 as amended by the Borough of Hemel Hempstead (Traffic Regulation No. 1) Order 1964. Paragraphs 3, 5, 6, 8, 9 and 10 of the Second Schedule to the Borough of Hemel Hempstead (Traffic Regulation No. 1) Order 1970, Article 3(a) and paragraphs 5 and 6 of the Second Schedule to the Borough of Hemel Hempstead (Various Roads) Traffic Regulation Order 1971. Paragraph 3 of Schedule 1 to the Dacorum District Council (Various Roads) (Prohibition and Restriction of Waiting) Order 1976. Schedules 1 and 3 to the Dacorum District Council (Marlowes, Hemel Hempstead) (Prohibition and Restriction of Waiting) Order 1980. Item (b) of Schedule 1 to the Dacorum District Council (Various Roads) (Prohibition and Restriction of Waiting) Order 1983 as it relates to the east side of Marlowes, Hemel Hempstead. Schedules 2 and 3 to the Dacorum District Council (Marlowes and Moor End Road, Hemel Hempstead) (Traffic Regulation) Order 1984. The Dacorum District Council (Marlowes, Bridge Street and Waterhouse Street, Hemel Hempstead) (Prohibition and Restriction of Waiting) Order 1983. Paragraphs (a) and (b) of the Schedule to the Dacorum District Council (Marlowes, Moor End Road and Selden Hill, Hemel Hempstead) (Prohibition and Restriction of Waiting) Order 1984 as it relates to the east and west sides of Marlowes. Paragraph 1 of Schedule 4 to the Borough of Dacorum (Various Roads) (Prohibition and Restriction of Waiting) Order 1987. Schedules 1 and 2 to the Borough of Dacorum (Marlowes, Bridge Street and Waterhouse Street, Hemel Hempstead) (Prohibition and Restriction of Waiting) Order 1987. The Schedule to the Borough of Dacorum (Marlowes, Hemel Hempstead) (Prohibition and Restriction of Waiting) Order 1988.

## (2) To prevent any vehicle from proceeding in the length of road specified in Schedule 1.

## (3) Exemptions from this will permit entry for:

- (a) emergency service vehicles;
- (b) a pedal cycle when not being ridden;
- (c) a pedestrian controlled vehicle;
- (d) an electrically operated invalid chair;
- (e) a security vehicle;

and, where necessary, in connection with:

- (f) building, industrial and demolition operators;
- (g) supply of gas, electricity and water;
- (h) any statutory powers of a local authority;
- (i) servicing kiosks and other buildings with the permission of the Council by way of permit; and
- (j) the management and maintenance of buildings with the permission of the council by way of permit; and

## (4) To prevent any vehicle to enter or proceed in the lengths of road specified in Schedules 2, 3 and 4.

## (5) Exemptions from Schedule 2 will permit entry for:

- (a) emergency service vehicles;
- (b) a pedal cycle when not being ridden;
- (c) a pedestrian controlled vehicle;
- (d) an electrically operated invalid chair;
- (e) a Royal Mail vehicle;
- (f) a disabled person's vehicle;

and, where necessary, in connection with:

- (g) supply of gas, electricity and water; and
- (h) any statutory powers of a local authority.

## (6) Exemptions from Schedule 3 will permit entry for:

- (a) emergency service vehicles;
- (b) a vehicle providing a local service;
- (c) a school bus;
- (d) a works bus;
- (e) a scheduled express carriage;
- (f) a hackney carriage;
- (g) a Royal Mail vehicle;
- (h) a vehicle with the Council's permission to proceed to the length of road specified in Schedule 1;
- (i) a security vehicle;

and, where necessary, in connection with:

- (j) any building, industrial and demolition operations with the permission of the Council by way of a permit;
- (k) supply of gas, electricity and water;
- (l) any statutory powers of a local authority; and
- (m) the management and maintenance of buildings with the permission of the Council by way of a permit.

## (7) Exemptions from Schedule 4 will permit entry for:

- (a) emergency service vehicles;
- (b) a vehicle providing a local service;
- (c) a school bus;
- (d) a works bus;
- (e) a scheduled express carriage;

and, where necessary, in connection with:

- (f) any building, industrial and demolition operations;
- (g) supply of gas, electricity and water;
- (h) any statutory powers of a local authority; and
- (i) the management and maintenance of buildings with the permission of the Council by way of a permit.

Full details of the proposals are in the draft Order, which together with plans showing the lengths of road affected and a statement of the Council's reasons for making the Order, may be examined during normal office hours at the Department of Law and Administration at the address given below. Any objections to the proposed Order must be made in writing to the Director of Law and Administration stating the grounds on which they are made by 20th November 1992.

Marlowes, Hemel Hempstead, between the junction with Bridge Street and a point 30 metres north of the junction with Moor End Road.

## SCHEDULE 2

Marlowes, Hemel Hempstead, from the junction with Moor End Road, northwards for a distance of 30 metres.

## SCHEDULE 3

Bridge Street, Hemel Hempstead, eastbound carriageway between the junctions of Waterhouse Street and Marlowes.

Marlowes, Hemel Hempstead, northbound carriageway between the junctions of Bridge Street and Hillfield Road.

## SCHEDULE 4

Marlowes, Hemel Hempstead, southbound carriageway between its junctions of Hillfield Road and Bridge Street.

Bridge Street, Hemel Hempstead, westbound carriageway between its junctions of Marlowes and Waterhouse Street. (798)
