#### HEREFORD AND WORCESTER COUNTY COUNCIL

*The County of Hereford and Worcester (A449, Wells Road and Peachfield Road, Malvern Wells) (Prohibition of Waiting) Order 1992.*

*The Hertfordshire (A4145 Tolpits Lane, Watford) (Prohibition of Overtaking) Order 1992*
