*Oxfordshire County Council (A4095, Long Hanborough) (40 m.p.h. Speed Limit) Order 1992*

Notice is hereby given that on Thursday, 22nd October 1992, the Oxfordshire County Council made the above order under section 84 of the Road Traffic Regulation Act 1984. *Oxfordshire County Council (A418 Oxford—Aylesbury Road and A329 Rycote Lane, Thame) (De-restriction) Order 1992*

#### PENDLE BOROUGH COUNCIL

##### *Traffic Regulation Orders*

Notice is given that the Borough Council of Pendle pursuant to arrangements made under section 101 of the Local Government Act 1972, with Lancashire County Council in exercise of the powers of the said County Council proposes to make the following Orders under sections 1(1) and 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984:

*The Borough of Pendle (Peel Road, Colne) (Prohibition of Waiting) Order, 1992*

The effect of the Order will be to:

- (i) prohibit waiting at any time on the south side of Peel Road, Colne, from its junction with Middle Street to its junction with Cross Street West;
- (ii) prohibit waiting at any time on the west side of Middle Street, Colne, from its junction with Cross Street West to its junction with Peel Road.

*The Borough of Pendle (Tatton Street/Cuerden Street) (Prohibition of Driving/Waiting) Order 1992*

The effect of the Order will be:

- (i) to prohibit driving in a north-easterly direction on the unnamed rear street which links Tatton Street with Cuerden Street, Colne;
- (ii) to prohibit waiting at any time on the north-west side of unnamed street which links Tatton Street with Cuerden Street, Colne;
- (iii) to prohibit waiting at any time on the south-east side of the unnamed street which links Tatton Street with Cuerden Street, Colne for 8 metres in a south-westerly direction from its junction with Cuerden Street.

*The Borough of Pendle (Reedley Road and Reedfield, Brierfield) (Prohibition of Waiting) Order 1992*

The effect of the Order will be to prohibit waiting between 3 p.m. to 4 p.m., Mondays to Fridays, on the north side of Reedley Road, from its junction with Hillside Avenue, to its junction with Pennine Way.

*The Borough of Pendle (Commercial Street, Barnoldswick) (Prohibition of Waiting) Order 1992*

The effect of the Order will be to prohibit waiting at any time on the east side of Commercial Street, Barnoldswick from a point 20 metres from its junction with Green Street, for 15 metres in a northerly direction.

*The Borough Council of Pendle (326-332 Railway Street, Nelson) (Prohibition of Waiting) Order 1992*

The effect of the Order will be to prohibit waiting at any time on the south-west side of Railway Street, Nelson from a point level with the north-west gable of No. 326 Railway Street for 15 metres in a south-easterly direction.

The Orders will contain exemptions for emergency vehicles, vehicles used in connection with the construction and demolition works, the maintenance of roads, the supply of gas, electricity or water or of any telegraphic lines as defined in the Telegraph Act, 1878, and local authority vehicles used in pursuance of statutory powers or duties.

Copies of the Orders and of the relevant maps showing the proposals and a statement of the Council's reasons for proposing to make the Orders can be inspected at Nelson and Colne Town Halls during office hours.
