###### *Amendment of Conservation Area at Dovercourt*

Notice is hereby given that the District Council have determined that the area described in the Schedule to this notice has been affected by a review of the existing designated Conservation Area at Dovercourt and that amendments have taken place with respect to the boundary designated in July 1986.

The effect of such designation is that by section 69 of the Planning (Listed Buildings and Conservation Areas) Act 1990, except for certain specified exemptions, no building shall be demolished without prior consent of either the District Council, as local planning authority, or the Secretary of State for the Environment and it is an offence punishable by fine or imprisonment, or both, to fail to obtain such consent. Under section 211 of the Town and Country Planning Act 1990 similar consents must be obtained before any tree situated in the Conservation Area is felled or lopped.
