ROAD TRAFFIC REGULATION ACT 1984

The M4 Motorway (Baglan, West Glamorgan) (Temporary 40 m.p.h. Speed Limit) Order 1992

Notice is hereby given that by reason of works proposed to be executed on the London-South Wales Motorway (M4) (hereinafter referred to as "the motorway") the Secretary of State for Wales has made an Order under section 14 of the Road Traffic Regulation Act 1984.

The effect of this Order is to temporarily impose a 40 m.p.h. speed limit in that length of the motorway which extends from a point 50 metres south-east of the centre-point of Baglan Roundabout to a point 100 metres east of the junction of the main eastbound carriageway of the motorway with the eastbound exit slip road at Pentyla Junction.

This restriction is anticipated to commence on Wednesday, 28th October 1992, and will remain in force until the said works are completed, which is expected to be around the end of 1994. (486)

PUBLIC INQUIRY

London Lorry Ban

Notice is hereby given that the Secretary of State for Transport has ordered a Public Inquiry in relation to the proposal by the Councils of London Borough of Bromley, Bexley, Croydon, Havering, Redbridge and Wandsworth to make on Order amending the Greater London (Restriction of Goods Vehicles) Traffic Order 1985. The Inquiry will be held under paragraphs 7(4) of Schedule 5 to the Local Government Act 1985.

The 1985 Order imposes restrictions on the movement of heavy goods vehicles in London at night and at weekends. The general effect of the proposed Order is to remove these restrictions so far as they apply in those London Boroughs.

The Inquiry will open on Tuesday, 5th January 1993, and will be held in the Council Chamber, Bromley Civic Centre, Stockwell Close, Bromley BR1 3UH. The Inspector will be Mr. T. M. Millington C.Eng., M.I.C.E., Dip.T.E. The Inquiry will consider objections and representations to the draft revocation orders which were published in November 1990.

A Pre-Inquiry meeting has been fixed for Wednesday, 4th November 1992, at 10 a.m., again at Bromley Civic Centre. At that meeting, the Inspector will wish to discuss arrangements for the full Inquiry. All those who consider there is any possibility that they or their authority/organisation may wish to give evidence to the full Inquiry in January should attend the 4th November meeting.

Proposed stopping-up of highways at Skelmersdale, Lancashire
