Derby City Council (Off-Street Parking Places) Order 1993

Notice is hereby given that the Derby City Council propose after the expiry of one month after the date of this notice to make an Off-street Parking Places Order which will amend the existing Charges Structure to that described in the Schedule to this notice.

The Order will also increase "excess" charges for non payment and overstay, and introduce excess charges for unauthorised parking in a place reserved for a disabled person's vehicle and parking other than in a marked bay.
