the above Act or on the grounds that any requirement of that section or of Part III of Schedule 9 of the Act, or any regulation made under the said Schedule has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

The Order will be operative as from 30th October 1992.
