SOUTH SOMERSET DISTRICT COUNCIL

The District of South Somerset (Brympton and Yeovil Without) (40 m.p.h. Speed Limit) Order 1992

Take notice that the South Somerset District Council, as agents for the Somerset County Council, have, on 22nd October 1992, made an Order under section 84(1) and (2) of the Road Traffic Regulation Act 1984, the effect of which will be as set out below, with effect from 30th October 1992:
