### ENVIRONMENTAL PROTECTION ACT 1990

The Secretary of State hereby gives notice that, having consulted the Committee established under section 140 of the Environmental Protection Act 1990, it is his intention to make regulations under that section to prohibit the supply of unauthorised fuel in smoke control areas, whereby no person shall in a smoke control area supply by retail sale for any purpose any solid fuel, other than an authorised fuel, which—

- (a) can be burned in a domestic fireplace, and
- (b) is to be carried away by the purchaser.

It is proposed that these regulations will come into force on 10th January 1993.
