The Borough of Bournemouth (Prohibition and Restriction of Waiting) Order 1981 (Variation) (No. 8) Order 1992

The Borough of Bournemouth (Boscombe Grove Road) (Prohibition of Traffic) Order 1992

Notice is hereby given that the Council of the Borough of Bournemouth (hereinafter referred to as "the Council") pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Dorset (hereinafter referred to as "the County Council") in exercise of the powers of the County Council under sections 1(1), 2(1) to (3), 3(2), 9, 10 and part IV of the Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, intend to make the above Order.

When the Order is effective, the restrictions listed in the Schedule to this notice will apply.

Exceptions will permit waiting for the purposes of picking-up and setting down passengers, loading and unloading goods and, where necessary, in connection with the maintenance of roads and the supply of gas, electricity and water, unless specifically stated otherwise.

A map showing the restricted areas and a statement of the Council's reasons for proposing to make the Order may be examined at:

- (ii) Springbourne Library, Holdenhurst Road: Monday and Tuesday, 9.30 a.m. to 12.30 p.m. and 1.30 p.m. to 5 p.m., Thursday and Friday 9.30 a.m. to 12.30 p.m. and 1.30 p.m. to 7 p.m., and Saturday 9 a.m. to 1 p.m.
