

- (ii) *Smallbrook Lane*, south side, from the junction with *Westleigh Lane* for a distance of 15 metres in an easterly direction.
- (iii) *Westleigh Lane*, both sides, from the junction with *Corner Lane/Smallbrook Lane* for a distance of 15 metres in a southerly direction.

The Wigan Borough (Richmond Drive, Leigh) (Prohibition of Waiting) Order 1992

The effect of the Order will be to introduce no waiting at any time on the following lengths of road:

- (i) *Richmond Drive, Leigh*, north-east side, from a point 10 metres north-west of the northerly kerb-line in the access road, adjacent to No. 14 *Richmond Drive*, to a point 10 metres south-east of the same access road.
- (ii) *Richmond Drive, Leigh*, north-east side, from the north-westerly kerb-line in *Coronation Drive* for a distance of 15 metres.
- (iii) *Richmond Drive, Leigh*, south-west side, from the north-westerly kerb-line in *Coronation Drive* for a distance of 130 metres.
- (iv) Access road adjacent to No. 14 *Richmond Drive, Leigh*, both sides, from the north-easterly kerb-line in *Richmond Drive* for a distance of 40 metres.
- (v) *Coronation Drive, Leigh*, both sides, from a point 15 metres south-west of the south-westerly kerb-line in *Richmond Drive* to a point 15 metres north-east of the north-easterly kerb-line in *Richmond Drive*.

On both of the above Orders there will be limited exceptions permitting vehicles to wait:

- (a) to enable people to board or alight;
- (b) for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers;
- (c) for local authority, North West Water Ltd and Post Office purposes;
- (d) if the vehicles are fire service or police vehicles or ambulances;
- (e) to take on fuel, water or air at any garage; or
- (f) for the delivery or collection of goods and for loading or unloading.

Copies of the proposed Orders, and of the relevant maps, and statements of the reasons for proposing to make the Orders may be inspected at the New Town Hall, Library Street, Wigan and Leigh Town Hall between 9 a.m. and 4.30 p.m., on any day from Monday to Friday.

Any objections to the above Orders must be made in writing and specify the grounds thereof and must be made to the Borough Solicitor, New Town Hall, Library Street, Wigan, not later than 27th November 1992.
