## The London Borough of Southwark (Waiting and Loading Restriction) (Amendment No. 72) Traffic Order 1992

Notice is hereby given that the Council of the London Borough of Southwark on 6th November 1992 made the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (x) as amended by Schedule V Part 1 Paragraph 4 (3) (a) of the Local Government Act 1985 (y).

2. The general effect of the Order would be further to amend the Southwark Waiting and Loading Restriction) Order 1976 so that in the lengths of the streets specified in the Schedule to this notice:

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 8 a.m. and 6.30 p.m. throughout the week in the streets specified in Schedule 1 to this notice; and between 8.30 a.m. and 6.30 p.m. throughout the week as specified in Schedule 2.
- (b) the present waiting and loading restrictions specified in Schedule 3 to this notice would be revoked.

3. The prohibitions referred to in paragraph 2(a) and (b) above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" will apply.

4. The prohibitions referred to in paragraph 3(a) and (b) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" will apply.
