The Stopping-up of Highways (Wyncliffe Road, Pentwyn, Cardiff, South Glamorgan) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up of the highway described in the Schedule to this notice to facilitate the relocation of a gatehouse, for which planning permission has been granted, to be carried out.

ENVIRONMENTAL PROTECTION ACT 1990

The Secretary of State hereby gives notice that, having consulted the Committee established under section 140 of the Environmental Protection Act 1990, it is his intention to make Regulations under that section implementing in part Council Directive 91/173/EEC (OJ No. L85/34) which amended for the ninth time Directive 76/769/EEC (OJ No. L262) on the marketing and use of certain dangerous substances and preparations. The Regulations restrict the marketing and use of pentachlorophenol, its salts and esters (PCP), and the use of wood treated with PCP inside buildings and in the manufacture of containers and packaging materials. It is proposed that the Regulations will come into force on 31st December 1992.

A draft of the proposed regulations and a descriptive consultation paper has been deposited at the Department of the Environment, Room P3/006, 2 Marsham Street, London SW1P 3EB, and another at the Welsh Office Environmental Division, Cathays Park, Cardiff, Wales CF1 3NQ, and may be inspected, free of charge, during office hours. Representations may be made in writing to the Secretary of State during a period of 14 days from the date of publication of this notice.
